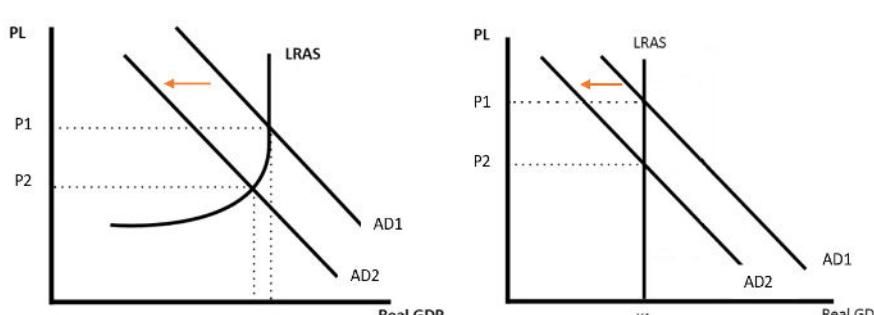

## General Marking Guidance
